Mayor Schoenig motions to open the meeting, Trustee Stockburger 2<sup>nd</sup> all in favor 4 to 0.

- 1. Bob Dumont Main Street no show.
- 2. Linda Wofford Family Day at Longview School Linda Wofford representing Longview School would like to do a family fun day and involve the local businesses and community together much like Founders Day. Seeking permission to close Main Street for a portion of the Village on a Saturday either May 24<sup>th</sup> or June 4<sup>th</sup> probably between 10 AM and 3 PM. Activities could include face painting, bounce-about, pony rides, three legged race, bake sale, vendors, battle of the bands or a "no talent contest," photo booth, tug of war, stiletto stampede, juggling contest, etc. and is open to suggestions. Jack Gress suggests the Longview School wrap their event into the existing Founders Day event.
- 3. Conference Attendance Water Superintendent continuing education requirements
  - a. Trustee Stockburger motions to authorize expenditures for DPW Superintendent Dan Crawford to attend the conference at a cost not to exceed \$1,000 for continuing education requirements as water superintendent, Trustee Boissonnault 2<sup>nd</sup> all in favor 4 to 0.

The Longview School request is a for-profit event and perhaps the Village should charge for the services the Longview School might expect if they choose to do it independently of Founders Day.
