## 7. Other Business -

- a. Deputy Mayor Piccini discusses the Micro Enterprise Grant. There are 4 interested properties who have applied. Since there are only four interested parties, should we go forward? Mayor Schoenig asks if we should go forward and reach out for more participants. Deputy Mayor Piccini reiterates that this grant has not generated much interest. The general consensus of the board is to continue to pursue the grant and try to generate more interest.
- b. Trustee Stockburger discusses the status of the flower baskets. We have all the flowers in hand and they will be planted and hung shortly. There is some interest in some personalized flags for banners on Main Street but no decision has been made as yet.
- c. Trustee Bryde discusses the Carmel Ave. Bridge inspection report. The bridge is in rough shape and this report depicts structural damage. Deputy Mayor Piccini asks if Engineer Folchetti can weigh in sooner rather than later.
- d. Trustee Boissonnault asks about the status of the Williams Gas Station construction as the excavation is still open and no work has been done lately.
- e. 571 N. Main Mayor Schoenig asks where we stand. Counsel Molé says he will confer with Jennifer Herodes and find out where the court matter stands.
- f. Deputy Mayor Piccini asks about the Blight Study contract status. Hansen has been in touch with Ferrandino and has a logistics meeting scheduled for May 24<sup>th</sup>.
- g. Deputy Mayor Piccini asks Counsel Molé about the Town water customers in arrears. Counsel says he was in court to discuss the Mitts matter last week and further submittals are forthcoming.

- a. Trustee Bryde and Trustee Boissonnault spent time with DPW Superintendent Dan Crawford going over the Village infrastructure and have first-hand knowledge of the water/well field status now and understand the need to replace the well field panel.

- c. Trustee Boissonnault asks about whether it was going to work out having a part time code enforcement officer. Mayor Schoenig says it seems to be the way other municipalities are working now as well.
