- 5. Rte 6 Culvert NYSDOT There is a sink hole under the sidewalk at the catch basin on Route 6 Eastbound. DOT came on site and put some rocks in the hole and a metal plate on top of the hole as a temporary fix. There is a large void under the sidewalk between the roadway and the retaining wall. The retaining wall is bulging because of the lack of substance underground. We need to take action as DOT does not seem to be doing so and NY law indicates it is the municipality's responsibility to maintain the substrate under state roads.

- b. Trustee Bryde attended the Blight Study meeting with Hansen and Ferrandino and Associates and is pleased the project is moving forward in an organized fashion. Trustee Bryde also mentioned the Oak street sign is still present.
- c. Trustee Boissonnault spoke with the DPW Superintendent to coordinate the street sweeper for Village streets.
- d. Mayor Schoenig asks about water regulations. Counsel Molé found that there is no limitation on penalty charges other than it be written into the code directly or by reference to a resolution. Mayor Schoenig asks about the Carmel Ave. Bridge, Mayor Schoenig is actively interviewing a 2nd Code Enforcement Officer and has selected someone to pursue. Team Brewster is tomorrow at 10AM at Walter Brewster House. Counsel advises the water arrears case is still pending and 571 N. Main is scheduled for late June in court.

- a. Trustee Boissonnault is researching a sign for the entrance to the Village on Rte. 6 by Hillside Ave. Cost could be \$2,500 to \$4,000 but we need a design before proceeding further. There was some discussion regarding multiple organizations helping to fund the sign.
