Mayor Schoenig motions to open the regular meeting, Trustee Stockburger 2nd all in favor 5 to 0.

1. Little League Parade Permit – Representative from Little League in attendance, Mayor Schoenig motions to approve the Little League Parade Permit for April 21st for 9:15 to 11:00 with a rain date of April 22nd, Deputy Mayor Piccini 2nd all in favor 5 to 0.

- 2. Bob Dumont Artbeat Parade Permit Mr. Dumont walked the routes with Chief Del Gardo and they shared their thoughts with each other. Insurance will be through Chamber of Commerce, waivers will be signed. Looking for cooperation with local property owners for parking so as to minimize traffic congestion. Mayor Schoenig motions to approve the parade permit for Artbeat on May 5th, June 2nd, July 7th, and August 4th, starting time is 9:00AM, ending time is 4:30PM on the sidewalk between the Train Station and Walter Brewster House, Deputy Mayor Piccini 2nd all in favor 5 to 0. Mayor Schoenig motions to approve the film Festival on September 2nd on Oak Street from Merritt to Brewster Coop (about a block off Progress, street to be blocked for food vendors from 2:30PM to 7:00PM, Trustee Stockburger 2nd all in favor 5 to 0.
- 3. K9-1 Proclamation of Appreciation & Recognition Mayor Schoenig motions to approve the K9-1 proclamation, Trustee Stockburger 2nd all in favor 5 to 0.
- 4. Women of Distinction Deputy Mayor Piccini mentions the Garden Club contributes a lot of time and energy to the beautification of the village and there are several women there who make those contributions. The criteria for nomination are to either live or work in the Village of Brewster. Trustee Bryde agrees with Deputy Mayor Piccini's comments. Tabled until the end of the meeting.
- 5. Peaceable Hill Water Mayor Schoenig notes that the cost of the Peaceable Hill water investigations is mounting. The Village has hammered out a framework of an agreement in lieu of their continuing expending monies on development of their own water source. The Village of Brewster is looking at various rate linkages between the Village & Town that would reduce the cost to Peaceable Hill residents. The idea is to create an agreement that outlives this board and provides security for the Peaceable Hill water consumers. Deputy Mayor Piccini asks how we would secure the rate linkage should we change our rate structures. Mayor Schoenig says the agreement would allow for that and ensure we do not single out Peaceable Hill for rate increases. The intention is for all water rates would be raised or lowered mutually between the Village & Town. Ms. Berman suggests the Village consider using a tiered rate the same as the inside village users for Peaceable Hill.

Mayor Schoenig motions to go into Executive Session with Judge O'Rourke, Deputy Mayor Piccini 2nd all in favor 5 to 0. Mayor Schoenig motions to come out of executive session and resume the regular meeting at 8:50 PM, Deputy Mayor Piccini 2nd all in favor 5 to 0.

- 6. Unpaid taxes to County Mayor Schoenig motions to approve the wholly unpaid taxes to be sent to the County as of February 1, 2012, Deputy Mayor Piccini 2nd all in favor 5 to 0.

- 8. Declaration for 450 North Main Street Counsel Mole advises that the declaration is to validate for deed restriction filing the conditions upon which the rezoning was granted. Deputy Mayor Piccini motions to approve, Trustee Stockburger 2nd all in favor 4 to 0. Mayor Schoenig Abstains.
