Mayor Schoenig motions to open the Public Hearing, Trustee Boissonnault 2nd all in favor 4 to 0.

Public Hearing

Revisions to the Fine Schedule and related language in Chapter 250 of Village Code entitled "VEHICLES AND TRAFFIC." Erin Meagher complained about bicycles being chained to street signs and would like the board to take action to prohibit. No other public comment.

Mayor Schoenig motions to close the Public Hearing, Trustee Boissonnault 2nd all in favor 4 to 0.

Mayor Schoenig motions to open the regular meeting, Trustee Stockburger 2nd all in favor 4 to 0.

Regular Meeting

- 1. Hudson Valley Cerebral Palsy Association Emergency Shelter Howard Yeager and Melissa Kamin. Mayor Schoenig would like to add a link to HVCPA on our website. Miss Kamin says there is no information regarding this capability on their website and asks we wait until they have a chance to fortify content. Mr. Yeager says the building is a 48,000 square foot building very well appointed. The building houses 7 different programs including a medical clinic serving the community. The building has natural gas and a generator providing continuous power. There are cots in the basement to provide for an influx. One thing still lacking is completed commercial kitchen designed to feed 600 people. When funding becomes available they will finish the kitchen. In the meantime it is still available as an emergency shelter. Mayor Schoenig asks how will we communicate with your staff if there is an emergency. The mechanics of the plan still need to be fleshed out but it is relatively simple to access the facility and Putnam County Emergency Services is aware of the facility's use. Mayor Schoenig would like this discussion repeated at a Team Brewster meeting to further raise awareness.
- Parade Permit Founders Day Erin Meagher provided the parade permit application and a letter describing the
 event and requests of the village. Mayor Schoenig motions to approve the parade permit for Founders Day from
 7AM to 5PM on September 30, 2012. On-street parking will be blocked off the day before; from Main Street at Oak
 to Main Street and Hoyt will be closed the day of, waiving fees, Trustee Bryde 2nd all in favor 4 to 0.
- 3. Budget Report We took a hit on Park Street sink hole, unbudgeted. The budget did not include the Code Enforcement Officer payment to Town of Southeast, money will have to be transferred for both items either from Fund Balance or Contingency or a combination thereof. Insurance premium stayed the same and we had budgeted a 10% increase. However, Workers Comp was higher than budgeted with the potential for a rebate but uncertain that will happen this budget year if at all. We have begun scrutinizing every office supply expense and are using

Amazon whenever favorable pricing can be had. We are still waiting for a new electric supply contract which may help us and will make some gains against phone service with the switch to Cornerstone. Jetting of sewer mains is another unbudgeted expense we must incur to keep the lines clear. This could prove to be a very challenging year but we are vigilant in every regard possible. All suggestions for savings are welcome.
