Mr. Alan Patrie representing St. Lawrence O'Toole Catholic Church appears before the Board to request a parade permit for the Corpus Christi Procession to be held on June 18, 2017 (assembly at 3:45) starting at 4:00 PM at Main Street and Railroad Avenue eastbound and left onto Progress Street, past Hoyt Street to Prospect Street and ending at 5:15 PM at St. Lawrence O'Toole Catholic Church stopping at intervals for prayer sessions. Mayor Schoenig motions to approve the parade permit as written waiving all fees, applicant to notify the fire department and coordinate with Brewster Police Chief Del Gardo, Deputy Mayor Piccini 2nd all in favor 5 to 0.

- 2. 2017 fiscal year-to-date Budget Report Treasurer Hansen provided the 2017 year to date budget report and says with the recent budget transfers and amendments we are on track to finish the year at the adjusted budget plan. Fund balance in the General Fund should increase this year while Water, Sewer and Refuse should remain as previously forecast.
- 3. Summer hours Mayor Schoenig motions to institute summer hours for the Village Office, Court, and Department of Public Works starting the day after Memorial Day, Tuesday, May 30, 2017; Village Office, Court & DPW will report to work ½ hour early each day and leave 2 ½ hours early on Fridays. 8:00-4:00 Monday through Thursday, 8:00-1:30 Friday. Normal hours, 8:30-4:00 Monday through Friday, to resume the day after Labor Day, Tuesday, September 5, 2017.
- 4. Memorial Day wreath Mayor Schoenig motions to authorize the purchase of a wreath to honor the fallen Veterans on Memorial Day at Southeast Veterans Park (Electrazone Field), Trustee Boissonnault 2nd all in favor 5 to 0.
- 5. Set Public Hearing for Proposed Local Law 3 of 2017 amending Village Code Chapter 205 Section 205-6 Removal at Owners Expense ..."If the owner fails to remove such materials, the Village may provide a notice to the owner to remove said materials within twenty four (24) hours. Upon the owner's failure to remove such materials within the prescribed time period, then the Village may cause such materials to be removed, in which case the cost thereof shall be assessed against the subject real property." Deputy Mayor Piccini motions to set the public hearing for Local Law 3 as

written for May 17, 2017 at 7:30 PM at Village Hall, 50 Main Street, Brewster, NY 10509 or as soon thereafter as time permits, Mayor Schoenig 2nd all in favor 5 to 0.

- 8. Other Business
 - 8.1. Deputy Mayor Piccini said the Town of Southeast moved their Town Board meeting to an earlier hour and did not notice the change properly so the meeting was over by the usual 7PM start time.
 - 8.2. Trustee Meagher said Terri Stockburger will help with the flowers for Main Street.
 - 8.3. Trustee Meagher said that Earth Day clean-up days went well.
 - 8.4. Trustee Bryde said she has been working with Paloma Domenica on the Village Matters newspaper for the Chamber 60th anniversary celebration at Wells Park on August 6, 2017. Clerk Hansen thanks Trustee Bryde for going above and beyond to help Paloma with the Chamber's vintage theme of the sixtieth anniversary at Wells Park. Trustee Bryde asked Trustee Meagher if she has turned in her article on Earth Day cleanup yet. Trustee Meagher said she has not completed it yet. Trustee Bryde said we are running up against the hard deadline and still have to do layout, formatting, and editing in time for the May 17th Board meeting for approval.
 - 8.5. Trustee Bryde attended the Little League opening and said it was a very nice turnout as usual despite the rainy weather.
 - 8.6. Trustee Bryde noted we received an announcement from Putnam County about the opening at Tilly Foster Farm of Tilly's Table for dinner and brunch beginning June 3rd & 4th.

9. New Business

- 9.1. Deputy Mayor Piccini motions to authorize the Mayor to sign and send the correspondence regarding Peaceable Hill Water arrears to the Town Supervisor and Town Council. Trustee Meagher 2nd, all in favor 5 to 0. Mayor Schoenig says we should also craft a letter canceling the 1980 agreement since the new agreement has to be signed by the Town just as every other user outside the Village water user is required to do.
- 9.2. Trustee Boissonnault says there will be a planting day at Wells Park on May 13, 2017 at 11:00
- 9.3. Mayor Schoenig says we received a request for a Peaceable Hill district easement from Mrs. Piazza, a landowner adjacent to Riverside Drive. We believe there is no easement to grant because we don't own the road because it is an easement of ingress egress between Peaceable Hill Road and our well field and pump house property. Mayor Schoenig says if an easement is needed and we are legally able to provide, the Town just needs to ask.
- 9.4. Mayor Schoenig has asked to meet with Senator Murphy regarding the Carmel Avenue Bridge.
- 9.5. Mayor Schoenig says that Village Hall needs interior maintenance including a wainscoting, painting, and chair rails.
- 9.6. Mayor Schoenig says the clock is twenty minutes fast, Verdin has been contacted and we are awaiting a service call that we expect to be covered under warranty.
